SCHEDULE AND SPECIFICATIONS

<u>Sl. No.</u>	<u>Description of Work</u>
1.	Dismantling of old dilapidated gents toilet (including toilet fixtures, RCC counter/lintel, half/full brick work, taking out of internal pipe lines of toilets as required) at 2 nd and 3 rd Floor.
2.	Repairing of roof of toilet at 2 nd Floor to stop seepage.
3.	Providing and applying 12mm to 15mm thick plaster to masonry and rec walls etc. in cement mortar 1:4 (1 cement:4 fine and coarse sand) finished smooth including hacking the surfaces for the both toilets.
4.	Providing and fixing of Ceramics Tiles of approved quality in specified size & colour in walls, cladding, dado, skirting inclusive of existing surface.
5.	Providing and constructing half brick masonry of thickness 115mm for all heights and levels using selected quality burnt clay FPS brick of class designation 75 in super structure laid in cement mortar 1:4 (1 cement :4 coarse sand) mix point finished, flush /raked to 6mm depth including providing and placing 2 numbers of 6mm dia plain bar at every fourth course .
6.	Providing , installation, testing & commissioning of sanitary Fixtures: (i) Water closet with water sensor (Made in India). (ii) Wash Basin with water sensor (Made in India). (iii) Health Faucet with water sensor (Made in India). (iv) Angle Valve (Made in India). (v) Bottle Trap (Made in India). (vi) Paper holder (Made in India).
7.	Providing & fixing CPVC B-Class pipeline with all fittings Elbow, Bend, F.T, M.T, Socket, ball valve, Teflon Tape, Reducer all complete.(Make : Astral,Supreme)
8.	Providing & laying of 100 mm dia 6kg Pressure PVC Pipe for water outlet with bends, sockets, etc. all complete (Make: Astral,Supreme).
9.	Providing and fixing of two each pillar cock in wash basin counter in the both toilets.
10.	Providing and fixing of three each Urinal Flush in the both toilets.
11.	Supplying and fixing of one each soap Dispenser in the both toilets.
12.	Supplying and fixing of eight each floor trap in the both toilets.
13.	Supplying and fixing of five each Bib Cock in the both toilets.
14.	Providing and fixing of three each Urinal (Hindware Make) in the both toilets.
15.	Shifting of all malba/debris from building.

1. Central Tax Commissionerate, Delhi South, 2nd & 3rd Floor, Annexe Bhawan, EIL, Bhikaji Cama Place, New Delhi-110066 invites tenders (Technical bid - Annexure-A, and Financial bid - Annexure-B, separately) for Renovation of 02 Existing Toilet Blocks of dimension size 20'X15'X10' cu.ft.
2. The Tender documents may be downloaded from e-procurement website 'GeM' i.e. 'Government e Marketplace' Online submission of bid/quotation through the Central Public Procurement Portal GeM is mandatory. Manual/Offline bid/quotation shall not be accepted under any circumstances.
3. The Bidders are requested to visit the website GeM regularly. Any changes/modifications in the Tender will be intimated by corrigendum through this website only.
4. The last date for submission of bid/quotation is upto 1700 hrs on 06.03.2018. The bid/quotation shall be opened at 1130 hrs on 08.03.2018. In case, any holiday is declared by the Government on the day of opening, the bid/quotation will be opened on the next working day at the same time.
5. In case only one bid/quotation is received, another extension of 7 days will be given and after that the bid/quotation so received will be evaluated.
6. The Commissioner, Central Tax, Delhi South Commissionerate reserves the right to accept or reject any or all the bids without assigning any reason, whatsoever. The decision of the Commissioner in this regard shall be final and binding on all.
7. If at any stage, before/ after the tendering process, it is found that any of the details/documents furnished by the bidder is false/ misleading/fabricated, then his/her bid would be liable for rejection/disqualification with suitable charges in that regard. If such rejection/disqualification occurs after the bid/quotation have been opened and the highest bidder gets rejected/disqualified, then the Principal Commissioner, Central Tax, Delhi South Commissionerate reserves the right to consider the next bidder or take any other measure as may be deemed fit including annulment of the selection process.
8. At any time before the due date for submission of the bid/quotation, the Assistant/Deputy Commissioner (Admin) may for any reasons whether at his own initiative or in any response to a clarification requested by the firms, modify the NIT (Notice Inviting Tender) documents by amendments which will be uploaded in the website.
9. The bid/quotation shall be opened at 11:30 hrs. on 08.03.2018 in the presence of the bidders who choose to be present during the opening of the bid/quotation. The Technical bid/quotation will be opened first and the financial bid/quotation will be opened later as per the Schedule mentioned in the Notice.
10. The bid/quotation for which a notice of withdrawal has been submitted shall not be opened. Only those bid/quotation that are received on or before the due date and time and which contains all the information as desired shall be considered.

11. The agency will have to comply with all legal provisions relevant for this purpose.




